

David Hendrick Memorial

Associated Builders and Contractors Dedicates Training Center in the Name of David R. Hendrick (July 8, 2015 Press Release)

GEORGIA – The Associated Builders and Contractors (ABC) of Georgia recently dedicated its training center in the name of the late David R. Hendrick, Esq., of the law firm Hendrick, Phillips, Salzman & Flatt. One of the association's most impactful members, Mr. Hendrick passed away in September of 2014. The official dedication took place on June 19, 2015, at ABC of Georgia Headquarters in Sandy Springs.

Mr. Hendrick was an active member of ABC of Georgia for more than 30 years. At the time of his death he had been serving a term on the board of directors since 2012. Mr. Hendrick also served as the association's legal counsel from 1998 – 2010.

Over 50 individuals attended the dedication ceremony, at which a bronze plaque was unveiled bearing Mr. Hendrick's likeness and an inscription. Phil Greeves, CEO of JAMCo, Inc., and 2015 chairman of the board for ABC of Georgia, along with Jim Taylor, former president of Balfour Beatty Construction and ABC of Georgia's chairman of the board in 1990, officiated the ceremony.


"David gave his time and talents to ABC for over 30 years," said Greeves. "He will truly be missed for his wisdom and his dedication to our industry." Taylor added that Mr. Hendrick's commitment to educating the construction community was unmatched. Mr. William D. Flatt, Esq., partner at the law firm founded by Mr. Hendrick, spoke of Mr. Hendrick's achievements as a top construction attorney, and of his life as husband, father and grandfather.

The plaque's inscription reads: "In recognition of his tremendous contributions to ABC and Georgia's entire construction community, this training facility shall be forever known as The David R. Hendrick Training Center."

Mrs. Emily Hendrick, Mr. Hendrick's wife of 46 years, attended the proceedings and thanked the association for the "tremendous honor."

A long-time member of ABC's Management Education Committee, Mr. Hendrick was one the association's most prolific and well-regarded presenters on construction law, and presented hundreds of seminars during his career. As a member of ABC's Legislative Committee, Mr. Hendrick was very involved in assisting with legislative initiatives relating to licensing, lien rights and bonding issues. On behalf of ABC, he was involved in the legislatively appointed task groups that shepherded the general contractor licensing statute and massive lien law revisions through the legislative process over the past decade. He was also a member of the ABC National Contract Documents committee. In 2011, Mr. Hendrick was recognized by ABC of Georgia as a "Champion of Free Enterprise and Open Competition" for his support of and ongoing service to the organization. He was deeply committed to ABC's mission and philosophy, and to continue to serve toward that end.

ABC of Georgia represents nearly 300 of Georgia's commercial and industrial contractors, subcontractors, suppliers and service firms, representing more than 2,500 employees. ABC supports the merit shop philosophy of construction that emphasizes free enterprise and open competition.
