President's Update

I write this note on a beautiful, idyllic Labor Day in Lexington. As is typical for our August meeting, we heard the report of our Membership Committee, chaired this year by John Bulman. After receiving the extensive due diligence accounts of the Committee and their recommendations, the Board voted to invite 8 new Fellows to the College. As you know from the August 27th communication, these names are confidential until the requisite 30 days has passed. Assuming no comments that must be resolved, we can freely

The ACCL Foundation is ready to submit its application for 501(c)(3) status, and the ACCL Board voted to provide \$45,000 seed money to the Foundation. This funding is a one-time event, as all other funds for the Foundation will come from donations. We are excited to see the Foundation grow.

The Diversity Committee reported on its mentorship program to assist younger construction lawyers develop their careers. Buzz Tarlow is also posting a podcast of the Annual Meeting diversity program.

We also decided to post all of the 2020 Annual Meeting presentations on the ACCL website, at no cost to Fellows, conditioned only on the consent of the presenters. We ask that Fellows not forward the presentations outside of the ACCL. The 2020 meeting presentations were fantastic, and I hope you will find easy access to the programs helpful.

Eileen Diepenbrock, Program Chair of the 2022 Annual Meeting, is putting the final touches on an outstanding program on large complex projects. As if that task were not enough, she has put together a webinar, with the help of Leslie O'Neal, on our ethical obligations to be current and fluent in technology. This webinar is scheduled for September 30th, and I hope you'll consider tuning in.

Golf at the Annual Meeting will be on Thursday instead of Saturday this year. The golf course is not close to the hotel, and it has proven difficult in the past to get golfers to a distant course after Hot Tips, and back in time for the dinner. 


Family vacation

Allen Gibson – Went on his annual beach vacation, with his family, here is a picture of them enjoying their summer vacation.




New life: new achievements



Gregory Hummel – Is pleased to share that he has been selected the 2021 recipient of the Leadership in the Private Sector Award for this year's March of Dimes Construction & Transportation Awards luncheon to be held on October 1, 2021. The committee noted his work on behalf of Chicago Mayor Lori Lightfoot's Invest Chicago South & West initiative.

As the chairman of the Chicago Central Committee, he worked with the executive director to empanel 10 who prepared schematic teams designs, market studies, financial plans development and strategies (hereinafter "CCAC materials") focused on specific corridors on Chicago's South and West sides. These CCAC materials in turn formed the basis of the Requests for Proposals that went to private sector teams comprised of majority and minority developers.

One notable feature of this initiative was the 250 community roundtables held primarily virtually to gauge community interest in the materials the CCAC teams had assembled. They discovered the ability to mount a multiple stakeholder process that has resulted in over \$270M in public sector assistance that is now married to projects having more than \$300M in private sector investment.



What surprised them was the follow-on investment that has already started to occur around the city designated sites in these 10 corridors.

The annual Construction and Transportation Awards is a unique event that honors industry companies, organizations and individuals and serves as an opportunity to recognize local leaders and projects that have made a difference in Chicagoland's infrastructure and in the community.

This year marks the 27th year of this awards event, and proceeds support March of Dimes and their mission to lead the fight for the health of mothers and their children.
