Message from John. R. <u>Heisse</u>

Perhaps the most important job of the President Elect of the College is to chair the Membership Committee, which vets the nominations of new Fellows, with an eye toward ensuring the future of the College through the admission of the "best and the brightest" of construction lawyers from within the U.S., and, on occasion, beyond. It is thus fitting that one of the final duties of an Immediate Past President is to chair the Nominating Committee – the committee charged with ensuring the more immediate future of the College, by advancing a slate of one candidate for an officer position and four candidates for our Board of Governors. I was joined by Kathy Barnes and Steve Charney in performing this task, and am very pleased to report that if our slate is elected at the business meeting at the Montage, Kathy, Steve and I are



very confident that the College will have steady hands at the helm.

For the position of Treasurer, to replace incoming President Elect Shelly Ewald, we nominate Terry Brookie. Since becoming a fellow in 2006 (in a class with John Bulman and me, by the way), Terry has co-chaired the Insurance Committee, served a threeyear term on the Board, served a twovear term on the Membership Committee, served as Program Chair for the 2019 Annual Meeting in St. Petersburg, co-chaired the History/Archives Committee for more years than I can count, and has spoken at our meetings on several occasions. To say that Terry has proven himself up to the task is an understatement – few among us have given as much to the College as Terry. So, of course, that means we will now ask him to do more!

When asked why he was interested in serving on the Board, he produced a thoughtful list of areas where we could improve our processes to both enhance the College experience for each of us,

but also to increase our outreach beyond our rolls.

Although it appears that pandemic-related issues may keep me from joining you in Laguna Niguel, and I will therefore likely miss our business meeting, I hope you will all enthusiastically vote for this slate of nominees, thereby ensuring that your current Board and Officers have the support of five energized and dedicated Fellows to replace those of us who will rotate off at the meeting.

Finally, I would be remiss if I didn't recognize and thank the three Board members other than Albee who will complete their terms at the annual meeting: Kathy Barnes, Eileen Diepenbrock, and Jim Schenck—each of whom has served or is currently serving as your Annual Meeting Program Chair in addition to their Board service. I can tell you from experience that there is no greater (or demanding) service a Fellow can give the College than to serve as Program Chair. Please join me in thanking Kathy, Eileen, and Jim for all of their hard work, and valuable advice. We truly cannot thank them enough.


Forget Greg's "horse power;" check out Sarah's dog power!!!!!
